In consideration of the promises and intention and for the consideration aforesaid, the FOUNDER doth hereby declare that the TRUST shall stand Possessed of the ~~said~~ said sum of Rs.1,000/- (Rupees One thousand only) and any property that may here after be transferred and conveyed to the TRUSTEES or the Trust and all future donations, grants, and subscriptions and contributions to the Trust from the FOUNDER or other persons, and the interest, rents, dividends, profits and income thereof and the stocks, funds properties and securities in / (future for the time being representating the same upon trust for the following objects.

(a) upon trust in the first instance to collect interest, rents, dividends, profits, and other income of the trust property, and from and out of the same, in the first place pay all proper costs, charges and expenses, of an incidental to the management, administration and execution of the trusts and Powers herein contained.

OBJECTS:

Subject to the Provision of Sub-Cause (a) of this clause, the TRUSTEES shall hold the TRUST Property upon trust so that the income thereof, and if necessary the corpus or any part thereof shall be used for all or any of the following objects and purposes for the benefit of the Public.

1. To establish, create, open, run, continue the educational medical, engineering, Polytechnic, Institutions, industrial institute and other allied nature of institution or institutions and vocational institution in healthy surroundings.

2. To engage teachers, Professors, instructors and experts of good moral character and capable to impart efficiently and economically upto date instruction to students in modern sciences, industrial avocations, research work, intellectual and other usual pursuits.

3. To establish, maintain and run boarding house and residential accommodation for students, those connected with the institution.

4. To develop a healthy as well as critical attitude towards the development of mental, Physical and moral Uplift of the students and those connected with the institution so as to make them good citizens.

5. To establish, take over, acquire, maintain and manage charitable hospitals, clinics, laboratories, dispensaries, medical research centres, and to provide free medicines, medical and surgical advice and aid to the Poor.

6. To take on lease, any hospital, clinic, laboratory, dispensary, or medical research centre, and to maintain and manage them.

7. To render financial assistance to any charitable institutions, and in particular any hospitals, industries, educational, institutions, libraries, orphanages, creches and homes for the aged and handicapped.

8. To award Scholarships or stipends in India to students to enable them to prosecute their studies in India, To give books, and to award prizes to students for proficiency in any subject or Language.

9. To promote study and research in any subject and above facilities those who conduct such study and research on any subject.

10. To give financial or corporal aid or ther help to indigent persons.

11. to render meaningful services to the Poor or to the needy by incorporating and implementing educational schemes like formal and non-formal andadult education for men, Women and children etc., and give vocational training for economic activities like handicrafts, tailoring etc., and social welfare programmes such as health, child and family welfare etc. and do other community development projects for them.

12. To provide extension activities and render services by starting branches of the Trust for the benefit of the weaker sections of society in any place or places and for promoting the aims and objects of the Trust among the people the/as may deem fit.

13. To publish books, booklets, house journals, magazines, newspapers and notices etc., in furtherance of the abovesaid objects.

14. To accept donation, grants, presents and other offerings and to deal with the same for the purpose of the trust to raise or borrow funds, amounts from any person as loan or advance in furtherance of development and interest and welfare of the trust.

15. To charge moderate tutition fees and otherwise recoup themselves for the outlay and expenses incurred in the upkeep

and maintenance of institutions established or about to be established under this deed.

16. To train and equip the Pupils so as to be self-supporting in an honourable and decent way of life so as to develop into good, healthy and progressive citizens.

17. To develop discretionary conduct and habit to observe the rule of law and self-restraint.

18. To bring out, encourage and development, inventive and research facilities of the Pupils and teachers and to afford opportunity for research work in art, science and industrial undertakings.

19. To promote contemporary art, paintings and to preserve to the glorious heritage and to provide infrastructures for the above said objects.

20. To hold, conduct seminars, meetings, get together symposium and other nature of allied meetings to promote the art, culture, science, research educations other studies and to hold group discussions for the betterment and upliftment of the People irrespective of caste, creed, religion, community, etc.,

21. To invest the trust fund and its income that may not be required or necessary for the purpose of carrying out the objects of the Trust, in immovable properties, shares and debentures in Government controlled companies, Government securities, deposits in Bank or banks or limited companies with Power of the Trustees to vary such investments from time to time into other or others of the same nature.

22. To purchase/or to construct one or more building or to take lease of land and buildings or to purchase other immovable property or properties for the functioning of the Trust and its projects in order to effectiveliy achive the objects of this Trust.

23. To purchase or acquire furniture, equipments, and all other movable things and properties as may be necessary or proper for maintining and conducting the Trust, projects and schemes and for providing the facilities and undertaking the activities at such places as may be decided upon and otherwise to give effect to the above objects of the Trust. To take on lease any school, college, University or to establish, run, school colleges, polythenics, Libraaries and other institutes and to maintain and manage them.

24. To do all such acts, deeds and things as may be incidental or necessary or conductive to the furtherance of the above said objects and to the growth and all round development of the Trust. To do all such other lawful things incidental or conductive to the attainment of the above objects.

25. The aforesaid objects of the Trust shall be for the benefit of the Public, namely all persons in irrespective or religion, race, caste, Community or creed etc. The above objects shall be independent of each other and the trustee, may, from time to time set apart and apply funds of the trust for camping out any specific objects of the Trust as they deem fit.

Mr. M.MURUGESAN, shall be the Managing Trustee ~~xxxxxx~~ for his life Time.

The other trustees shall hold such office as Trustee during their life time unless they should vacate the office earlier for any reason whatsoever. In the event there being a vacancy in the Office of such trustees it shall be filled up by the mutual consent amongst the other trustees when the decision of the managing trustee thereto being the prevailing factor.

In the event of any vacancy arising in the office of Managing Trustee, other Trustees of the Trust shall, by mutual consent amongst themselves, elect either one of them or any of them or any other person whom they may wish to so appoint to do the Managing Trustee.

The office of the Trust shall be situated at Present at the following address: 19 Arcot Road, Virugambakkam, Madras- 600 092, or at such other place in India as the TRUSTEES may decide upon.

NOW THIS DEED WITNESSETH AS FOLLOWS:

WHEREAS the FOUNDER has paid a sum of Rs.1000/- (Rupees ONE THOUSAND only) paid on the 27th day of AUGUST 1993, to the said Trust.

The TRUSTEES shall hold the above sum of Rs.1000/- (Rupees One thousand only) paid on the 27th day of August 1993, to them to/by the FOUNDER upon the Trust, the receipt of whereof the TRUSTEES to hereby admit and acknowledge.

The Trustees hereby agree and solemnly declare that they will utilise the money transferred to the TRUST, for the Aims, Welfare and objects of the Trust mentioned above and will have a mutual duty to report and inform each other about all the affairs of the Trust at the times.

DONATIONS AND CONTRIBUTION

The TRUSTEES shall have Power and discretions to accept upon such terms as they shall think fit, any donations, grants, subscriptions, aid and contributions from the Founders or from any Government, Local Authority, Statutory, Corporation, Company, Firm or from any charitable Trust of other institution, or from any person, whether they be in cash or in other movable and immovable property, for the purposes of the TRUST, PROVIDED ALWAYS THAT the terms upon which they shall be accepted, shall not in any way be in consistent with or repugnant to the provisions contained in these presents. The Trustees shall apply such donations grants, aids, subscriptions and contributions, for all or any of the objects of the trust keeping in view as far as possible the intentions of the grantors.

INVESTMENTS

All monies which shall not immediately be required for current expenses, shall be invested by Trustee in investments and securities authorised by law for investment of trust funds, and in particular according to the Provisions of section 11 (5) of the Income-tax Act or other relevant Provision of law for the time being in force, or in such investments shall be in the names of the Trustees or in the name of the Trust with the approval of the Board.

NUMBER OF TRUSTEES

The number of Trustees shall not be less than three and they can co-opt ~~two~~ ^{are} two trustees and in total of the trustees ^{are} not more than five. The TRUSTEES named in these presents shall be the First TRUSTEES.

The Powers and functions of the Board of Trustees, and that of the Managing Trustee shall be as defined and detailed hereunder.

MANAGING TRUSTEE

1. The Managing trustee shall be Executive of the Trust and its establishments, and shall have the general administration of the Trust.

2. The Managing Trustee shall be entitled to appoint all employees upon such terms volunteers, and other personnel thereof, subject to the Budget allotment of the Trust upon such terms and conditions as to remuneration and other connected matters as he may deem proper, and to suspend, remove or dismiss any such persons so employed and to make other


provisions for their beneficts or otherwise, subject to the prior approval by the board of Trustee.

3. The Mananging trustee shall be receive all moneys on behalf of the Trust and deposit the same in any Scheduled bank or in a National Bank as approved and decided by the Board of Trustees in the name of the Trust, and he shall have powers to pay for and spend on approved items of expenditures, approved and retified by the board of Trustees.

4. The Managing trustee shall be the custodian of all the title deeds, records, and other approved document relating to the transactions and other matters of the trust, and he shall be in charge of all movable properties and things belonging to the Trust.

5. The Managing trustee shall maintain an accurate record of all receipts and payments, and disbursements during each month and place an abstract of the same every 6 months to the Board and the Managing trustee shall also prepare and place the Annual Report, at the Annual meeting of the Board of Trustees in the last week of November/December with a consolidated Statement of accounts settled on the 31st day of March of the Proceeding year, audited by a qualified auditor by every year, the period being Twelve months between April and March, unless the Board of Trustees shall fix any other date therefor.

6. The Managing Trustee shall operate all the bank account.



POWER OF TRUSTEES

The Trustees shall have all powers necessary or incidental for effectually carrying out the objects of the trust.

subject to the General Provisions of the Trust and without prejudice to the General and specified Powers conferred upon the Trustees by the other provisions contained in these presents, the Trustees shall have the following powers also;

1. To apply the trust monies to effectuate one object or some for the objects of the trust in preference to the other objects;

2. to discontinue the application of trust funds to one object and divert the funds to another object.

3. to decide whether and if so, what existing institution or institutions may be taken over by the Trust or to which financial aid may be given.

4. incase it is decided to render financial or other aid to any person or institution, to decide what terms and conditions shall be complied with by such institution.

5. To determin the terms and conditions on which any donations, subscriptions, Scholarships, prizes are to be given by the trust.

6. to expend the funds by the Trust in such manner as they shall consider most beneficial for the purposes of the Trust.

7. to acquire, build, upon, pull down, re-build, add to, alter, repair, improve, sell or dispose of, hire

for the use of the Trust or belonging to the Trust and to acquire any movable property required for the use of the Trust and to dispose of the same in any manner.

8. to take or transfer any property on lease or hire;

9. To acquire any property in exchange for some other Property or partly in exchange and partly for other consideration

m 10. To enter into any contracts on behalf of the Trust.

11. to Borrow any money upon the security of any of the Property of the trust and to grant mortgages or any other security for securing the same or without any security and upon such terms and conditions as the TRUSTEES may deem fit;


12. to make and from time to time to repeal, add or alter regulations.

a. for the management of the Trust and the affairs thereof;

b. as to the duties and remuneration and conditions of service of any officers or servants or employees of the Trust;

c. as to the conduct of any of the matters or things within the Powers or under the control of the Trustees provided that the same shall not be inconsistent with the provisions contained in these presents.

13. The Board of Trustees shall be eligible for honorarium and other allowances including travel allowances towards services rendered by them to the trust and the same shall be decided or prescribed by the BOARD specifically



according to the individual capacity and contributions by the Trustee, as they deem fit and proper and they may reimburse themselves or himself or herself or pay and discharge out of the trust fund all expenses properly incurred in our/or about the execution of the Trust of Power under these presents.

14. To commence, Prosecute, defend or to settle out of court, compromise or compound all suits, actions and any other proceedings and all differences and demands and to refer and submit to arbitration all, or any of such differences or demands, and to appoint advocates in relation to such proceedings, and to sign all pleadings, affidavits, and applications, in relation thereto, and to execute, release, and to settle, and approve all accounts, without being answerable for any loss occasioned thereby; and;

15. To appoint and dismiss, Punish and terminate, the services of managers secretaries, clerks, and all other staff and workers required for the working and for the generation/general management of the affairs of the Trust.

16. To make, drawn, execute, accept, endorse, discount, buy sell, transfer, pledge, negotiate or otherwise deal with, all bills of exchange promissory notes, cheques, bills of lading railway receipts registered on insured letters or parcels, or postal receipts, savings certificates stocks, shares and all negotiable instrument, and all commercial and transferrable documents and securities.

MISCELLANEOUS

17. (1) The Trustees consider that the objects of

Trust is ~~exempted~~ under the Income Tax Act. In case however a particular clause of the instrument of the Trust has been in advertently clothed in any language capable of an interpretation in conflict with the relevant provisions of the income tax Act, granting exemption, it is expressly declared that such clauses shall have restricted meaning or null and void, so that the relevant Income Tax Act and its provisions will always have the overriding affect.

18. The Trust shall be Irrevocable

19. The Trustees shall maintain proper books of accounts of the income and expenditure of the Trust which shall be closed every year. The Official year of the trust shall until the Trustees otherwise resolve which they are hereby authorised to do, be calculated from 1st April of the following years provided that the first year shall commence from the date of these presents ie., the first year shall be from the date of these presents to 31st March 1994. The books of accounts so maintained shall be audited by a quialified charatered Account every year.

20. The income and funds of the Trust will be solely utilised towards the object of the Trust and no portion of it will be utilised for payment to the Trustees by way of Profit, interest, dividends etc., except a reasonable remuneration for services rendered by the Trustees to the Trust and expenditure like travel charges, boarding loading and incidental incurred by them to undertake any travel for any matter relating to the Trust.

21. Any amendment to the Trust Deed shall be carried out only with the approval of the commissioner of Income tax.


22. It is expressly provided that the Trust will not carry out any activity outside India.

23. The Trust shall not carry out any activity with the intention of earning profit.


